The Special Council-in-Committee meeting was opened by the Mayor.

PECUNIARY INTERESTS

There were no declarations of pecuniary interest.

1. SHAMESS SUBDIVISION

Committee wished to discuss the Shamess Subdivision and in particular the letter from Novatech dated July 6, 2012.

Deputy Mayor Mohns made a presentation to Council that he thought could solve the matters outstanding. He presented a revised plan that took the parking lot from Block 17 and spread it across the bottoms of lots 3, 4 and 5.

Councillor Lemay arrived.

Deputy Mayor Mohns spoke of having a clause in the subdivision agreement to advise that Rantz Road will not be upgraded and he also spoke of brushing out some areas on Shamess Road to provide better sight lines.

There was a discussion of docks along Rantz Road and individuals using the Town property as their own.

Murray Chown asked for permission to speak and it was granted. This was his first look at this proposal but he was quite willing to look at it with his clients if Council generally supported the idea. There was a discussion on this matter and consensus of the majority was that it could be supported.

Councillor Lemay felt that people using the shoreline need to be told that they are using Town property and have no rights to it.

There was a discussion of the request to bring forward the Official Plan amendment and Zoning By-law amendment. Once a reply is received from the Shamess family these documents could be amended accordingly and proceed.

Mr. Chown thanked Committee for bringing this matter forward for further discussion and he felt the Town has the tools to accomplish what has been discussed.

2. FIRE DEPARTMENT

a) Activity Report – June

The report was received for information.

3. SIGN BY-LAW

The latest version of the sign by-law had been circulated. It has been through several rounds of public consultation. During last round there were two individual comments in regard to the regulations on portable signs.

Councillor Cirella asked about enforcing the by-law along county roads. Karen Cronier replied that efforts are being made to co-ordinate Town and County By-laws. We are still awaiting formal comment from the County to the last by-law draft.

Mayor Sweet advised he would follow up at the County. The by-law will be held awaiting these comments.

4. XENICA PRESENTATION

Mitch Stillman reported that Mark Holmes from Xenica will be making a presentation at Council on August 7 to update Council on the power project. The town has also received word that there will be a candle light vigil that night ending at the Town Office at 6:30 pm and the we expect a crowd from the general public to the meeting. Grant Tysick is also on the agenda to speak to the Xenica project from his perspective.

Mayor Sweet updated Council on discussions he has had with the Base Commander and the MNR District Manager on this subject. He reminded Committee the Town has no jurisdiction in this matter. He advised that the Base Commander did not support the Half Mile project and he is not sure on the other project. Town has been a neutral player to date but maybe down the road circumstances may change. There is also a public information meeting coming up. Council will have opportunity to ask questions following Mr. Holmes presentation on August 7.

5, LEVEL II DROUGHT

Mitch Stillman and Mayor Sweet updated Council on the Level II drought in Renfrew County and explained the sequence of drought categories and the repercussions of each. Mitch also explained the role of the Low Water Response Team (of which his Town representative) and the steps that the Town has taken in an attempt to meet the 20% voluntary reduction is water use as requested by the terms of the Level II drought. The

Town is providing water to those in rural areas who have had their wells run dry upon request.

6, CODE OF CONDUCT FOR COUNCILLORS

Councillor Lemay made a presentation on the rationale for a Council to have a code of conduct and provided a draft resolution for consideration. She explained that the Code would assist transparency, be proactive, a good way to reinforce responsibilities of council members and would be valuable for new Councillors.

There was a general discussion among the Councillors on pro's and con's of having a code of conduct including legislated responsibilities, the role of the electorate, and enforcement of violations of the code.

After discussion Councillor Lemay withdrew her motion, but it was:

- Protection of confidential information
- Discreditable conduct
- Employment of relatives
- Failure to adhere to council policies and procedures\
- Receipts of gifts and benefits
- Use of Town property

And that the ad hoc committee report back to a Council in Committee meeting within one month.
