PUBLIC MEETINGS

1. Official Plan Amendment #15 (from "Residential" to "Commercial") and Corresponding Zoning By-law Amendment (from "Residential One" to "Commercial-Holding") – 21 Murphy Road, 11758847 Ontario Inc.

The Public Meeting was opened by the Mayor at 6:35 p.m. Karen Cronier, Planning Coordinator, advised that the Notice of Public Meeting had been provided as required under the *Planning Act*. The Town did not receive any correspondence or comments. Ms. Cronier explained the purpose of the Official Plan amendment and the Zoning By-law amendment is to permit an extension to the Petawawa Town Centre commercial development. The effect of the Official Plan amendment is to redesignate the subject lands, being 3,885 square metres in area and containing an existing dwelling and garage, from Residential to Commercial. The effect of the Zoning By-law amendment is to rezone the subject lands from Residential One (R1) to Commercial-Holding (C-h). Ms. Cronier advised that the condition for the removal of the holding symbol to permit the development of the property is the approval of a site plan agreement by the Town under Section 41 of the *Planning Act*.

Mayor Sweet asked to hear comments from members of the public. Eric Withers, Planner with Jp2g spoke on behalf of the applicant to explain the location and that the entrance to this property will be off of Town Centre Blvd once that street has been built. Cathy Morris and Jonathan Faytone spoke about their concerns regarding development on this property. They live on Butler Blvd and their property backs on to the property in question. Their main concerns were the following; would there be any effect on the value of their property, effects on the animals and trees behind their property and whether a noise barrier or fence would be built. Eric Withers, Jp2g explained that at this time there is no proposed development for the property and that the purpose of the application is to establish the principle of development.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet thanked all for attending the meeting and declared the Public Meeting closed at 6:45 p.m.

2. Zoning By-law Amendment (from "Rural" to "Rural-Exception Fifteen") – Part of Lot 17, Concession 2, Pitzner Road, Hawkins

The Public Meeting was opened by the Mayor at 6:45 p.m. Karen Cronier, Planning Coordinator, advised that the Notice of Public Meeting had been provided as required under the *Planning Act*. The Town did not receive any comments or correspondence regarding the application.

Ms. Cronier explained the purpose of the Zoning By-law amendment is to permit a reduced minimum lot frontage requirement from 30 metres to 20 metres. The effect of the amendment is to rezone the subject lands, being 6,050 square metres in area, from Rural (RU) to Rural-Exception Fifteen (RU-E15). The amendment is a

condition to the granting of consent application B83/13, which is an application for a lot addition. All other provisions of the Zoning By-law shall apply.

Mayor Sweet asked to hear comments from members of the public. No one came forward to speak either for or against the application.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet thanked all for attending the meeting and declared the Public Meeting closed at 6:50 p.m.
