1. Activity Report – September 2016

Fire Chief Steve Knott provided an overview of the monthly report. Chief Knott reported that October 9th to 15th is Fire Prevention Week. Chief Knott highlighted three false alarm calls and confirmed that discussions were continuing with alarm companies regarding code regulations involving the placement of carbon monoxide detectors and response procedures. Chief Knott reported that regular vehicle maintenance and service was conducted in September and platoon training was focused on search and rescue related to structural fires.

Chief Knott provided an overview of the monthly report, indicating that 229 residences were inspected during the smoke and carbon monoxide check campaign. All residences were code compliant by the end of the process. Chief Knott reported that compliance with the fire regulations require smoke monitors to be located on every level of a residence and that carbon monoxide units be located outside sleeping areas. Chief Knott noted that the school activations this year were aimed at grades 3 and 7 as part of the educational component of Fire Prevention Week.
