## 1. Petawawa Housing Corporation – Jennifer Turcotte, Chair and Ed Chow, Treasurer

Jennifer Turcotte, Chair, and Ed Chow, Treasurer, for the Petawawa Housing Corporation (PHC) addressed Council-in-Committee to make a request for financial assistance in the amount of \$100,000 to support the building of 14 affordable housing units at 1145 Victoria Street Three possible financial assistance options were detailed and discussed. Mr. Chow indicated that without confirmed financial assistance from the municipality, the entire project and designated funding from the Investment in Affordable Housing Program could be lost to the Town, re-allocated to another community, possibly in another County.

A motion was put forward by Councillor Sabourin and seconded by Councillor Serviss to support the PHC in the amount of \$100,000, to be determined based on the Town's financial capacity, over two payments.

A discussion occurred with respect to requesting staff to review and recommend the method that Council would provide the funds. It was concluded that a more finite decision of Council would be tabled.

In order to facilitate the introduction of a new motion, Councillor Sabourin withdrew her original motion.
