COUNCILLOR REPORTS

Councillor Treena Lemay reported that the Petawawa Police Services Board is conducting a short survey with the aim of soliciting community input to be shared with the Ontario Provincial Police during the development of their 2017 Action Plan. Councillor Lemay also noted that the survey is an educational opportunity for the community to understand they have a voice and that the PSB is there to represent their interests. Surveys are available at the Municipal Office as well as online at www.petawawapsb.ca.

Councillor Murray Rutz reported that the Fall/Winter edition of the Community Guide was being circulated to resident's homes this week. Councillor Rutz encouraged residents to view the assortment of programs and events as well as the Town Times section within the guide.

Councillor Gary Serviss reported that visitors from Germany were complimentary of the Town and the many amenities, including the water fountain at Centennial Park.

Councillor James Carmody – nothing to report

Councillor Theresa Sabourin reported that she attended the Association of Ontario Municipalities Conference and took in various workshops including asset management, affordable housing, accessibility, risk management, climate change and legalization of marijuana. Mayor Sweet also confirmed his attendance amongst more than 1900 AMO registered participants. Mayor Sweet further indicated that he did not allow his name to stand for re-election to the AMO Board and executive.

Mayor Bob Sweet provided a verbal update on the water treatment plant, which was supported with the following press release:

Petawawa, ON – The water treatment plant at the Town of Petawawa experienced an electrical fire during the evening of August 16th, 2016. The fire resulted in damage to one of three motor control centres (MCC) operating within the plant. A MCC unit is an assembly of common power services that regulate and relay information amongst various motor starters and equipment interfaces. Ontario Clean Water Agency staff and contractors worked tirelessly to enact emergency management procedures and temporarily re-route electrical circuits and bring backup operational equipment online. With the Town capable of producing and distributing water, assessing the extent of the damage and analyzing long term solutions transpired.

A system investigation confirmed the necessity of replacing the electrical system and certain operational modules within the plant. The equipment requiring replacement are complex, engineered units that are manufactured by a limited number of suppliers. Equipment specifications and design approvals have occurred under an accelerated procurement process, however it will be late October before delivery of the equipment is anticipated. Upon receipt of the specialized equipment, systematic installation and careful integration into plant operations will occur to ensure continued water distribution.

To safeguard adequate water supply and prevent undue burden on the water plant processing system, the Town of Petawawa continues to enforce a non-essential water use ban. Excessive draw from the water treatment system could adversely affect the repairs implemented and cause further damage to the system network. We ask that residents refrain from watering their lawns, but normal daily household use is permitted.

"We appreciate the efforts of residents to comply with this water-use ban and acknowledge that the water restriction has been a deterrent to the maintenance, repair and sodding of neighbourhoods and homes within the Town of Petawawa," acknowledged Mayor Sweet. "The water use ban will remain in force to ensure that the Town can fulfill the core services of producing and supplying quality, safe water for consumption and fire suppression needs."

The Town wishes to thank residents for their patience and understanding during this time. Water conservation and proper asset management will ensure that residents continue to receive essential services until the necessary repairs can be fully completed.
