The Council-in-Committee meeting was opened by the Mayor at 6:31 p.m.

DISCLOSURE OF PECUNIARY INTEREST

There were no disclosures of pecuniary interest.

PRESENTATIONS

1. <u>Municipal Signage Program, Cyndy Phillips, Economic Development Officer, Kelly Williams, Manager of Parks & Recreation</u>

Cyndy Phillips presented a unified municipal signage concept that included signage for municipal infrastructure; buildings, parks, tourism, directional, trail, water access, neighbourhood and street name signs. The goal of adopting a common sign design is to create uniformity and brand identity for the municipality. Kelly Williams spoke to the Parks and Recreation Master Plan and the redevelopment of existing Town parks. Mr. Williams indicated that part of the 2016 plan for park rehabilitation included sign replacement. In a round table discussion, the municipal signage concept was well received however; there was consensus that at this time, they were not in favour of altering the current street name signs. Staff was directed to come forward with a final signage plan and definitive cost estimate. Ms. Phillips indicated that she would bring forward a recommendation at the May 24th Councilin-Committee meeting. Mayor Sweet thanked Ms. Phillips and Mr. Williams for their presentation.

2. Rural Recreation – "How To Use What You've Got," Colin Coyle, Recreation Coordinator

Mr. Williams introduced Colin Coyle, Recreation Coordinator, indicating that Mr. Coyle was asked to speak at the recent Parks and Recreation Ontario annual conference. Mr. Williams reported that recreational efforts made in Petawawa and

more recently in Renfrew County with the Healthy Kids initiatives are garnering positive provincial attention. Mr. Coyle shared his presentation, citing the factors changing the recreation environment, and shared how a shift in focus and a return to basic outdoor play using the existing natural environment was the new trend. Mr. Coyle shared statistics indicating that participation in traditional sports were declining nationally and new sports were on the rise; citing specifically, soccer and swimming. Mr. Coyle also cited reports and statistical correlation between declining physical activity and the increase in poor physical and mental health. Mr. Coyle highlighted the many recreational attributes that Petawawa has and shared some plans for future programs, emphasizing the need for partnerships, collaboration, risk management and idea sharing. Mayor Sweet thanked Mr. Coyle for his presentation and echoed the message that partnerships were key to providing recreational programs, referencing specifically the partnership between Valour School and the Town in their facility sharing.

PARKS & RECREATION

1. Activity Report – April 2016

Kelly Williams, Manager of Parks & Recreation, provided an overview of the monthly report. Mr. Williams reported that discussions with recreational user groups had been conducted regarding the proposed Pricing Policy. Mr. Williams also noted that the second challenge in the Healthy Kids Community Challenge was to create a natural play space. Assistance in concepts and discussion of further financing for this type of project is being provided through a consultant retained by Renfrew County. Mr. Williams noted that the annual Hell or High Water event was taking place on Saturday, May 14th, with a military day on the 13th. Mr. Williams also noted that Civic Centre Days was scheduled for June 10th -19th with Lobsterfest occurring on the 18th. Mr. Williams reported that the funding application to Celebrate Ontario 2016 for support of the Upper Ottawa River Race and Paddle Festival was not successful. Mr. Williams reported that local support of this event is increasing, as is more regional attention.
