PRESENTATIONS

1. Ontario Clean Water Agency Partnership with the Town of Petawawa

Mayor Sweet welcomed representatives of the Ontario Clean Water Agency (OCWA) and invited Aimee Hennessy, Business Development Manager to introduce those present. Ms. Hennessy introduced Rob Andrews, President and CEO, Andy Trader, Eastern Ontario Regional Manager and Brad Sweet, Petawawa Operations Manager.

Mr. Andrews provided an overview of OCWA's mandate and governance as a provincial Crown Agency, noting their vast infrastructure and human resource assets available through the collective partnership and economy of scale purchasing power. Mr. Andrews renewed OCWA's commitment to streamline and realize efficiencies throughout the organizational structure. Mr. Trader outlined the partnership in place with the Town since 1970, highlighting many of the services and plant operational improvements which have occurred over this time. Of key importance is a five year 100% compliance record at the water treatment facility. Ms. Hennessy summarized the presentation asking Council to consider exercising its option to negotiate the first renewal term of the services agreement as the current contract expires December 31, 2017.

Mayor Sweet thanked the group for their presentation and remarked on the reliable and collaborative partnership that the Town has experience with them. Mayor Sweet noted future work and upgrades to the water and wastewater plants and indicated that further discussions would occur.
