# **PRESENTATIONS**

1. <u>Petawawa Police Services Board 2016 Year End Report & Upper Ottawa Valley Ontario Provincial Police 2016 Year End Report – Councillor Treena Lemay, Chair & Inspector Mark Wolfe, Detachment Commander</u>

Councillor Treena Lemay, Chair of the Petawawa Police Services Board (PPSB) provided a presentation regarding the activities of the PPSB for the year 2016. Chair Lemay touched on items such as the legislated mandate of the police services board, Petawawa's action plan and goal setting. Chair Lemay introduced Sharon Dainty, who was appointed by the Province to the PPSB in March 2016. Chair Lemay recognized Inspector Mark Wolfe's permanent appointment as Detachment Commander of the Upper Ottawa Valley OPP Detachment in the fall of 2016. Chair Lemay also highlighted the future of policing and the growth of the local detachment; the distracted driving campaign and the Safe on 17 campaign; three successful grant applications; and the e-cop neighbourhood watch program.

Inspector Mark Wolfe introduced Chief Superintendent Chris Harkins, East Region Commander, and Acting Staff Sergeant Dean Duchrow. Inspector Wolfe provided an overview of the activities of the Upper Ottawa Valley OPP Detachment for the year 2016. Inspector Wolfe touched on items such as civilian data entry; focused patrol/directed patrol; analytics; victim services; traffic enforcement; community mobilization; OPP recruitment initiatives; and community relations. Inspector Wolfe highlighted the billable calls for service which were down by 269 calls over 2015 statistics, with weighted hours down by 879 hours compared to 2015 statistics.

Chief Superintendent Chris Harkins addressed Council and highlighted the modernization of the OPP to make the organization more efficient. Chief Superintendent Harkins explained that he oversees 16 OPP detachments as the East Region Commander.

Mayor Bob Sweet thanked Chair Lemay and Inspector Wolfe for providing a detailed summary of the activities of the PPSB and the Upper Ottawa Valley OPP for the year 2016. Mayor Sweet also thanked Chief Superintendent Harkins for attending.
