FIRE DEPARTMENT

1. Activity Report – August 2018

Fire Chief Steve Knott provided an overview of the monthly report. Chief Knott reported one vehicle fire, one fire alarm, one carbon monoxide alarm and attendance at five open air burning incidents (two were burning without a permit-charges are pending, two were unfounded, and one had a permit) occurred during the month of August. Chief Knott reported during the fire ban, July 4-August 10, 2018; 14 charges were levied against residents for burning infractions. Chief Knott also highlighted platoon training and ongoing equipment and vehicle maintenance.

1. Activity Report – August

2. PR-07-2018 – 2018/19 Parks and Recreation Department Rates and Fees

Kelly Williams provided an overview of the report. Mr. Williams reported that staff is recommending an increase to current selected rates by an inflationary factor of 2.2%, based on the CPI, effective September 1, 2018; adult ice rates will be increased by 4%; and youth ice rates will be increased by 5%. The recommendations are based on the Parks and Recreation Pricing Policy and the Pricing Policy Study completed in 2016.

2. <u>ADMIN-24-2018 - Animal Control/By-law Enforcement Activity Report-August</u> 2018

Dawn Recoskie, Deputy Clerk, presented the report. Ms. Recoskie highlighted the issuance of a set fine to a resident for repeatedly breaching the Animal Control Bylaw with respect to her dog running at large. Ms. Recoskie noted 12 warnings were issued for watering on the wrong day and/or time, and seven exemptions were provided to property owners to water newly laid sod or grass seed of substantial portion. Ms. Recoskie reminded residents to review the list of acceptable items which can be placed out for the large item collection this week, in their garbage schedule; she noted items such as toilets and construction materials are not acceptable. Further, Ms. Recoskie reported that a warning letter was hand delivered to a seasonal resident, with the assistance of the OPP, to refrain from driving his ATV on the beach at Petawawa Point Park and on the roadway (Island View Drive).
