A nomination must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 1, 2018 and July 26, 2018, and between **9:00 a.m. and 2:00 p.m.** on July 27, 2018 (**NOMINATION DAY**) and such additional nominations, if required may be filed in the office of the Clerk.

Electors are hereby given notice that if a greater number of candidates are certified than are required to fill said offices, voting places will be opened on the dates stated below for the purpose of voting.
