c. Enabling Accessibility Fund 2018

The application to the Enabling Accessibility Grant for the Civitan Playland Accessible Improvement project was successful. The project includes the rubberized resurfacing of the two remaining play structures, an asphalt pathway to the Kinhut and improvements to the washrooms and canteen at the Kinhut to make them more accessible. The total project was estimated at roughly \$66,164.00 with \$5,000.00 donated from the Civitan club and a request for support from the Enabling Accessibility Fund of \$39,089.00
