PUBLIC MEETING

1. Zoning By-law Amendment (from "Rural" to "Residential One") – Donald Rantz & Richard Rantz, Part Lot 14, Concession 7, being Parts 1 & 4 on 49R-19168, Rantz Road

The Public Meeting was opened by the Mayor at 6:32 p.m. Karen Cronier, Director of Planning and Development, advised that the Notice of Public Meeting had been provided as required under the Planning Act. The Town received correspondence from Enbridge Inc. which had no concerns regarding the application.

Ms. Cronier explained the purpose and effect of the proposed amendment is to rezone the severed lands in Consent Files B062/18(1) and B063/18(2) from Rural (RU) to Residential One (R1) as a condition of consent. All other provisions of the Zoning Bylaw shall apply.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet thanked all for attending the meeting and declared the Public Meeting closed at 6:34 p.m.

1. Delegation – Rantz Road Speeding Issues – Eric Perreault

Mayor Sweet welcomed Eric Perreault, to discuss concerns with respect to traffic and more specifically speeding on Rantz Road. Mr. Perreault's suggestion to close a portion of Rantz Road was not supported by Council.

Mayor Sweet thanked Mr. Perreault for his presentation and for bringing to light the concerns of residents along this stretch of roadway. Staff will review the material provided and assess the best resolution to resolve cited concerns, with the first step being to install the Speed Awareness Monitor (SAM) on Rantz Road in June to gather the appropriate statistics. The Petawawa Police Services Board will then discuss these statistics with the Detachment Commander of the Upper Ottawa Valley OPP to establish a schedule for a focused patrol.

2. Petawawa Accessibility Advisory Committee, 2017 & 2018 Year in Review – Sheila Clarke, Chair of the Petawawa Accessibility Advisory Committee

Mayor Sweet welcomed Sheila Clarke, Chair of the Petawawa Accessibility Advisory Committee (PAAC), to make her presentation on the projects and efforts of the PAAC in the past two years.
