# 2. <u>Draft By-law to Regulate and Prohibit Smoking on Municipally Owned Property in</u> the Town of Petawawa

Mitch Stillman presented the draft by-law. It was noted the by-law will be amended to exclude sidewalks and roadways from the definition of municipally owned property. Mr. Stillman advised staff was having difficulty meeting the 30 metre separation distance at the Civic Centre property to identify a designated smoking area due to the number of entrances to the building. Council directed staff to consider main entrances instead of all entrances such as ones considered "fire/emergency exits only".

Staff was directed to provide an alternate location for the designated smoking section if the 30 metre separation distance can't be met satisfactorily. Staff was further directed to include short form wording and set fines to aid in the enforcement of the by-law and to consider appointing other staff to aid in the enforcement of the by-law.
