### **PRESENTATIONS**

1. Petawawa Police Services Board 2012 Year End Report – Treena Lemay, Chair

Councillor Treena Lemay, Chair of the Petawawa Police Services Board introduced board member Pauline Wilson (municipal appointee) and Detachment Commander of the Upper Ottawa Valley Ontario Provincial Police (UOVOPP) Acting Inspector Jeff Smith. Chair Lemay provided a presentation regarding the activities of the Petawawa Police Services Board (PPSB) for the year 2012; she touched on items such as the mandate of the PPSB; the contract between the Town and the UOVOPP; policing services and activities; calls for service; motor vehicle collisions; community survey on satisfaction with policing services; revised website for the PPSB; selection of new senior staff for the UOVOPP; bike patrol activities; the rising costs of policing; unpaid Provincial Offences Act fines; and implications of the growth of the UOVOPP detachment.

Deputy Mayor Mohns thanked Chair Lemay, Ms. Wilson and Acting Inspector Smith for attending the meeting and providing a detailed summary of the activities of the PPSB and the UOVOPP for the year 2012.

She also advised that the next meeting of the Environmental Stewardship Committee will take place on March 25<sup>th</sup> where the Valued Ecosystem Components Report will be discussed.

He further reported that he attended CFB Petawawa on March 13<sup>th</sup> to hear an announcement from Peter MacKay, Minister of National Defence, regarding the new housing units to be constructed on the south and north sites, as well as confirmation of the new building to house the Canadian Special Operations Regiment (CSOR) and the construction of the new indoor shooting range.
