The cost to install chain link fencing is approximately \$40,000. Staff has requested that this item be budgeted for in 2014. To off-set the cost for fencing, staff is recommending that an annual user fee for the LFDP be set at \$20.00.

Staff was asked to consider re-using the chainlink fencing that was installed along the railway which will no longer be needed in that location, to reduce the costs of the new fencing for the dog park. Staff was also asked to install "no-smoking" signs at the dog park, and to consider an area in the dog park for "small dogs only".
