PRESENTATIONS

1. Addressing the Setting of Speed Limits and Speeding related issues in the Town of Petawawa - Councillor Treena Lemay, Chair - Petawawa Police Services Board

Councillor Treena Lemay, Chair of the Petawawa Police Services Board, presented her report "Addressing the Setting of Speed Limits and Speeding related issues in the Town of Petawawa" that was previously endorsed by the members of the Petawawa Police Services Board. Councillor Lemay reported that speeding on local streets and cut-through traffic in residential areas are the two most noted citizenreported concerns in many communities in Canada. Part 1 of Councillor Lemay's presentation focused on an examination of factors affecting speeds travelled on residential streets; Part 2 focused on a review of the researched effectiveness of common and currently used methods of controlling speed limits on residential streets; Part 3 focused on a suggested framework to standardize posted speed limits within the Town; and Part 4 focused on the solution (in part) of the implementation of traffic calming measures. Councillor Lemay's report provided 15 recommendations for consideration and possible adoption by Council.

Mayor Sweet and members of Council thanked Councillor Lemay for her very detailed report.
