1. Zoning By-law Amendment (from "Rural" to "Residential One") – Wayne Lemke (Agent Dugan Hawkins), Part of Lot 10, Range B, Gutzman Road

The Public Meeting was opened by the Mayor at 6:35 p.m. Karen Cronier, Planning Coordinator, advised that the Notice of Public Meeting had been provided as required under the Planning Act. The Town did not receive any written comments regarding the rezoning.

Ms. Cronier explained the purpose of the Zoning By-law amendment application is to rezone the severed lands in consent applications B155/14(1), B156/14(2), and B157/14(3). Each of the proposed lots is 7,800 square metres in area and the total area of lands being rezoned is 2.3 hectares. The effect of the amendment is to rezone the subject lands from Rural (RU) to Residential One (R1). The amendment is a condition to the granting of the above mentioned severance applications.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the rezoning application.

Ms. Cronier then explained the appeal process to those present in the audience.
