# 2. Capital Projects Update – July 2015

David Unrau provided an update to Council regarding current capital projects, asset management, energy management, waste management and water quality. Mr. Unrau reported that the Civic Centre Road project is underway, the Airport Road project has been awarded, the kick-off meeting has been held with OCWA engineers for the municipal office generator and the Renfrew Street pumping station generator, and the LED street lighting installation will begin in mid-August.

### 3. PW-21-2015 – Tender PW-09-2015, Truck with Plow, Dump Box and Hopper

David Unrau provided an overview of the report. Mr. Unrau reported that the tender price submitted by Valley Truck and Spring was \$137,424.89 plus HST, which was over the \$120,000.00 budget for this item. Since the vehicle will not be delivered until December 2015, it was recommended that the dump box item be removed for 2015 and re-budgeted for 2016. The removal of the dump box will bring the price down to \$123,729.25 plus HST; the resulting over expenditure will be funded by underspends elsewhere in the Transportation Budget.

# 4. <u>PW-22-2015 – Tender PW-11-2015</u>, <u>Sewage Treatment Plant Up-Grades to Clarifier</u>

David Unrau provided an overview of the report. Mr. Unrau reported that the tender price submitted by Rescom Coatings Inc. was \$373,900.00 plus HST, which was over the \$367,500.00 budget for this item including \$37,500 for consultant fees. The tender had a contingency of \$20,000.00 and a provisional item for coating the complete interior of the clarifier; the provisional item was quoted as \$150,000.00. Mr. Unrau reported that the area of the coating covered in the provisional item could be adjusted so that the overall project cost does not exceed the construction budget of \$330,000.00 + HST. It was recommended that the overall project cost be monitored, including the contingency, and that the coating area be adjusted to ensure the construction budget is not exceeded.

# 5. PW-23-2015 – Speed Hump Policy and Guideline

Mr. Unrau presented a revised traffic calming point assessment sheet and reported that both Mohns Avenue and Civic Centre Road met the minimum requirements for the installation of speed humps; the other streets assessed (Albert, Harry, Black Bay, Airport, Biesenthal, and Armstrong) did not meet the minimum requirements for the installation of speed humps.

Council then discussed the proposed policy and guideline. Some members of Council felt the policy was too restrictive and wanted it to have more flexibility. Council discussed legislation, enforcement, and education. There was no support from Council for the policy as presented.

The report was tabled at this time. Council was asked to provide their comments on amending the proposed policy to the CAO/Clerk.
