COUNCILLOR REPORTS

Deputy Mayor Tom Mohns reported that he attended the Remembrance Day activities which he termed a celebration of the sacrifices that veterans have made to protect and preserve our freedom.

Councillor Treena Lemay reported that she would be participating in a teleconference tomorrow to discuss the results of the Age Friendly Community Survey and the upcoming Age Friendly Community Forum on November 24th.

Councillor Theresa Sabourin reported that she attended the Legion's Remembrance Day dinner on behalf of the Mayor and Council.

Councillor Murray Rutz reported that he attended a Town Times meeting on November 9th and informed Council that a new concept would be used for 2016.

Councillor James Carmody - nothing to report.

Councillor Gary Serviss reported that he has received a number of positive comments from citizens whom are pleased with the new LED street lights that are being installed throughout the Town of Petawawa.

Mayor Bob Sweet reported that through the Association of Municipalities of Ontario (AMO) he had the opportunity to participate in two (2) Memorandum of Understanding meetings with the Government of Ontario. Mayor Sweet indicated that there were some fiscal challenges coming forward for municipalities, citing a further reduction in the Ontario Municipal Partnership Fund. Mayor Sweet spoke to areas of concern for AMO including the "Fire Medic" movement, changes to Bill 73, as it relates to planning terms and definitions, and climate change initiatives specifically targeting greenhouse gas emissions. Mayor Sweet also attended the Eastern Ontario Regional Network meeting and spoke about the cell phone gap analysis and search for funding programs to support this initiative. On a local level, Mayor Sweet spoke about the Economic Development Conference held by the Development and Property Department of the County of Renfrew, and the Ontario Highlands Tourism Organization conference which brought outside participants into the County. He also cited his participation in the MRI closing event and the sod turning for the new Canex on Garrison Petawawa. Mayor Sweet highlighted the excellent Remembrance Day ceremonies which he participated in at St. Francis of Assisi Catholic School, as well as his march with veterans during the Remembrance Day parade, and the Leliefontein ceremonies, as conducted by the Royal Canadian Dragoons. Mayor Sweet also invited the population to attend the Santa Claus parade this Sunday, November 22nd beginning at 1:00 p.m. and noted that the Council of Petawawa would be participating.
