# 2. <u>PL-02-15 – Consent Applications B149/14 & B150/14, Ivan Hoffman, Part of Lot 20, Concession 4</u>

- 2. A 15 metre vegetative buffer be required along the rear lot lines of both residential lots.
- 3. A 2.0 metre high solid wood fence be provided along the rear lot line of the lots to be severed.
- 4. A notice be placed on the title of both severed lots so that future purchasers are aware of the aggregate operations and the potential for noise and dust.
- 5. The applicant enter into a development agreement with the Town as a way to implement conditions 2, 3 and 4.
