BY-LAW 1310/19

BEING A BY-LAW TO PRESCRIBE A TARIFF OF FEES FOR THE PROCESSING OF APPLICATIONS MADE IN RESPECT OF PLANNING MATTERS IN THE TOWN OF PETAWAWA

WHEREAS the *Planning Act*, R.S.O. 1990, Chapter P.13, Section 69, as amended, provides that a Council of a Municipality may by by-law prescribe a tariff of fees for the processing of applications made in respect of planning matters;

AND WHEREAS Council deems it expedient to update the tariff of fees to reflect the cost to the municipality for processing applications;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PETAWAWA ENACTS AS FOLLOWS:

- 1. That Schedule "A" attached hereto, and forming part of this by-law, shall be adopted as the tariff of fees with respect to the planning matters indicated thereon for the Town of Petawawa.
- 2. That the fees collected under the authority of this by-law, relate to the costs incurred for the review, preparation of documents and processing as required under the *Planning Act*.
- 3. That the fees contained in Schedule "A" shall come into force and take effect on January 1, 2020.
- 4. That the tariff of fees imposed pursuant to this by-law shall be adjusted annually on January 1, without amendment to this by-law, in accordance with the Statistics Canada Quarterly, *Construction Price Statistics*, catalogue number 62-007.
- 5. That By-law No. 478/08 of the Town of Petawawa is hereby repealed.
- 6. That this by-law shall come into force and take effect following third reading.
