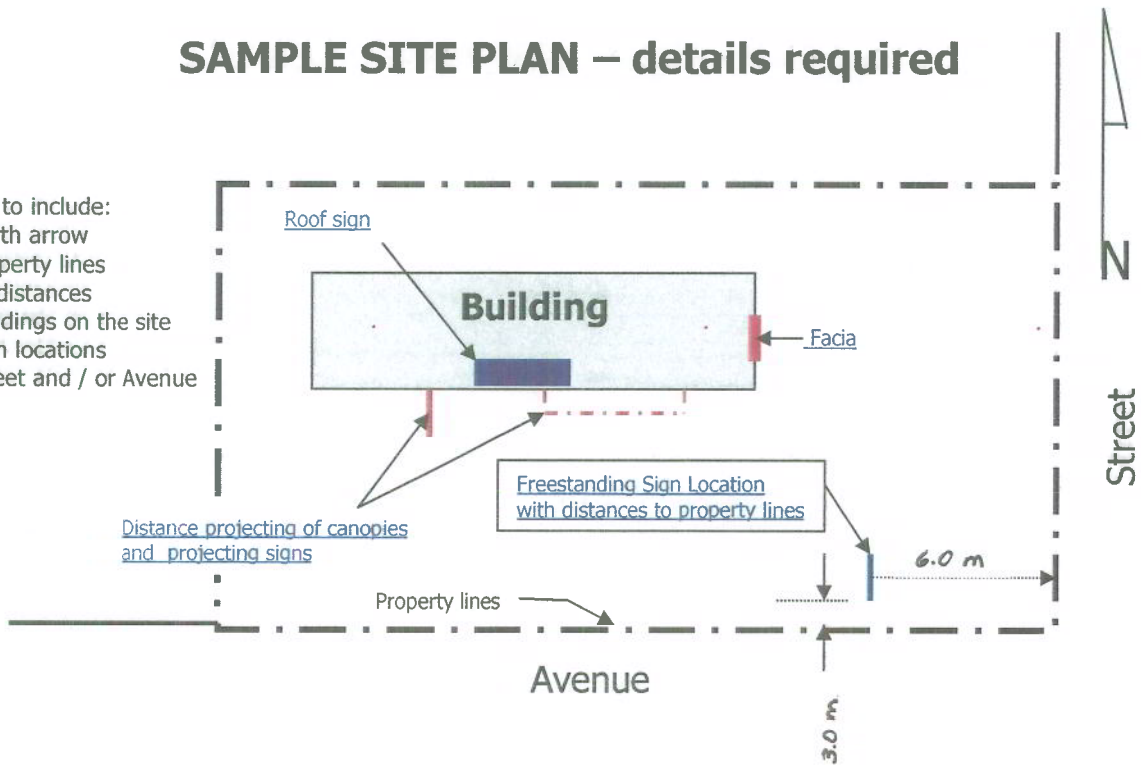

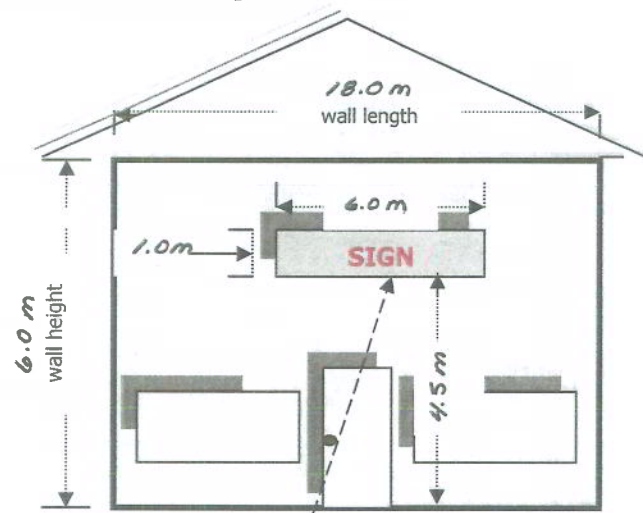
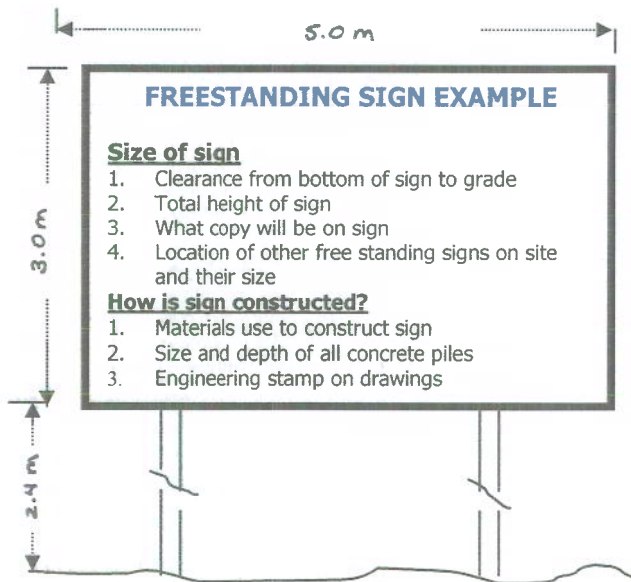
SAMPLE SITE PLAN – details required
