6. PW-11-2018 - Minimum Maintenance Standards for Municipal Highways

David Unrau provided an overview of the report. Mr. Unrau reported Ontario Regulation 366/18, amending Ontario Regulation 239/02 Minimum Maintenance Standards for Municipal Highways, received royal assent on May 3, 2018. Mr. Unrau highlighted the changes as follows: municipalities will be able to declare a

significant weather event relating to snow accumulation; there is a requirement to complete winter maintenance on designated bicycle lanes; sidewalks need to be inspected once per year, defects repaired within 14 days, and remove snow to less than 8 cm within 48 hours; and encroachments near sidewalks need to be inspected once per year.

Mr. Unrau reported staff will continue to review the new requirements and bring forward a report outlining new resource requirements prior to October 1, 2018. The report was received for information.

7. PW-12-2018 – Private Water Service for 2 Biesenthal Road

David Unrau provided an overview of the report. Mr. Unrau reported this request was initially brought forward to Council under report PW-12-2017 on June 26, 2017; at that time staff was directed to review the matter further to provide clarity on financial, engineering and liability concerns, Council tabled the report.

Mr. Unrau reported many discussions were held internally with staff and externally with consultants and legal. Mr. Unrau explained there is no defendable cost the Town could charge other than having the owner pay for 100% of the installation costs. The County of Renfrew would want the Town to be 100% liable for any maintenance/repair/replacement of the water service under Petawawa Boulevard and the Algonquin Trail right-of-way. Further, Section 16 of the Town's Official Plan discusses the goals, intent and objectives for connection to the water system; 2 Biesenthal Road is designated Rural Residential (private wells and septic systems). Mr. Unrau also noted the property does not front on Petawawa Boulevard.
