1. <u>Ernie Lafrance – Certificate of Appreciation in recognition of retirement from the OPP Auxiliary</u>

Mayor Sweet presented Ernie Lafrance with a certificate of recognition for his 16 years of service with the OPP Auxiliary and thanked him for his longstanding civic involvement.

PUBLIC MEETINGS

1. Zoning By-law Amendment (from "Residential One" to "Residential One-Exception Fifty One") – Turcotte, Part of Lot 1, Lake Range, Easy Street

The Public Meeting was opened by the Mayor at 6:36 p.m. Karen Cronier, Director of Planning and Development, advised that the Notice of Public Meeting had been provided as required under the Planning Act. The Town received correspondence from the Township of Laurentian Valley indicating no concerns regarding the application.

Ms. Cronier explained the purpose and effect of the proposed amendment is to rezone the severed and retained lands in Consent File B64/18 from Residential One (R1) to Residential One -Exception Fifty One (R1-E51). as a condition of consent. The severed and retained lots are required to be rezoned to reduce the minimum 30 metre frontage to 20 metres and alter the minimum lot area from 1400 square meters to 700 square meters. All other provisions of the Zoning By-law would apply.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet thanked all for attending the meeting and declared the Public Meeting closed at 6:38 p.m.

2. Zoning By-law Amendment (Residential Parking Provisions)

The Public Meeting was opened by the Mayor at 6:38 p.m. Ms. Cronier advised that the Notice of Public Meeting had been provided as required under the Planning Act. The Town received correspondence from Enbridge Gas Distribution and the Township of Laurentian Valley both respondents had no concerns regarding the application.

Ms. Cronier explained the purpose and effect of the proposed amendment is increase the number of required parking spaces from one space for single detached, semi-detached, duplex and two unit dwellings to two parking spaces. The amendment also increases the parking space requirement from 1.5 to 2 parking spaces for triplex, three unit, apartment and multiple attached dwellings.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet thanked all for attending the meeting and declared the Public Meeting closed at 6:40 p.m.

STAFF REPORTS

1. CAO-09-2018 – MPAC's voterlookup.ca

Daniel Scissons, CAO/Clerk, presented the report. Mr. Scissons highlighted the importance of an accurate Voters' List, noting that Petawawa residents can use www.voterlookup.ca until August 30, 2018 to update their information through this online platform. After this time, anyone needing to change their voting information, including confirming that they are on the voter list will need to attend the Municipal Office where staff will be able to provide them assistance to complete this process. Mr. Scissons reiterated that this election would include phone, internet and paper ballot voting options for eligible voters. Mr. Scissons indicated that it was important that election candidates and the media promote voterlookup.ca to residents.

The report was received for information.

Councillor Theresa Sabourin reported as Chair of the Pembroke and Area Airport Commission Rate Review Committee that work to review the airport fees structure was ongoing and a report of those findings would be forthcoming.

Councillor Gary Serviss reminded Council of the Upper Ottawa River Race and Paddle Festival taking place August 10th – 12th, specifically referencing the CHEO SUP charity race of which Councillors Carmody, Sabourin and Serviss are participating.

Mayor Bob Sweet reported on work completed improving the Algonquin Trail throughout Renfrew County, noting that while sections of the trail are open, work remains to be completed for the full trail system to be operational. Ontario Municipal Commuter Cycling funds, which were initially a five year grant program, have been cancelled; that funding was supported by the proceeds of the now repealed cap and trade program. New funding will need to be sought to continue the Algonquin Trail development, including the addition of infrastructure and 911 signage. Mayor Sweet provide a presentation to the Pembroke Kiwanis on this subject during their July 18th meeting.

Mayor Sweet reported attending five meetings at the County involving the Algonquin Trail, Ottawa Valley Recreation and CAO Recruitment Committee. Mayor Sweet also had a meeting with the Mayor of Pembroke, Mike Lemay. Mayor Sweet participated in the fundraising golf tournaments for the Rotary Club as well as the Royal Canadian Dragoons Armoured Corps. Mayor Sweet extended thanks to the Frank Cowan group for their support of our Neighbourhood Parks and Green Spaces development and highlighted the installation of a ½ court basketball they are supporting at Jack Pine Park.
