## **PRESENTATIONS**

1. Recognition of Volunteer Service – Ed Chow and Nick Chan – Petawawa Public Library Board

Deputy Mayor Gary Serviss, Chair of the Petawawa Public Library Board, presented certificates to both Nicholas Chan and Ed Chow for their exemplary volunteer service to the Petawawa Public Library Board. Mr. Chan was recognized for 8 years of volunteer service, serving as Secretary for the Board for 4 of those years, and Mr. Chow was recognized for 38 years of volunteer service, serving as Chair for the Board for 8 of those years.

Mayor Sweet congratulated both Mr. Chan and Mr. Chow for their volunteerism.

2. Petawawa Public Library 2018 Year in Review – Amanda Foster, CEO

Deputy Mayor Gary Serviss introduced Library CEO, Amanda Foster. Ms. Foster presented the Library's annual statistics which saw 72,643 visits to the Library, and 101,105 items were checked out in 2018. The Library's website was visited 46,523 times and public computer and Wi-Fi sessions were used 31,564 times. Ms. Foster highlighted new technology added to the Library's website including Flipster, Kanopy, and a Digital Heritage Collection.

Mayor Sweet thanked Ms. Foster for her presentation.

4. Community Safety and Well-Being Plans

Councillor James Carmody explained the introduction of Community Safety and Well-Being Plans (CSWBP) has been in the works by the Province for a number of years; it is a new model for intelligence led policing. Regarding the Eastern Ontario Wardens' Caucus' correspondence, Councillor Carmody acknowledged he can understand the group's concerns regarding the creation of CSWBP's. Conversely, Councillor Carmody took issue with the correspondence provided by Warden Jennifer Murphy which suggested that the upper and lower tier municipalities were opposed to CSWBP's and that their drafting would not be initiated. Councillor Carmody objected to the stance that the County was purportedly espousing on behalf of its constituent municipalities. As Chair of the Petawawa Police Services Board, Councillor Carmody is not opposed to CSWBP's and in fact he supports the creation of CSWBP's as it is the future of policing.

Mayor Bob Sweet provided clarification on the Warden's correspondence, indicating the County was not interested in creating a County-wide CSWBP.
