STAFF REPORTS

1. <u>PL-12-19 - Zoning By-law Amendment, VIMCO, Part of Lot 22, Concession 5, being Part 1 on Reference Plan 49R-19365, Water Tower Road</u>

Karen Cronier, Director of Planning and Development, provided an overview of the report. Ms. Cronier explained the purpose of the zoning by-law amendment is to rezone the subject lands from General Industrial (GM) to General Industrial-Exception Six (GM-E6) to permit a scrap iron and metal transfer and recycling centre. All other provisions of the Zoning By-law shall apply.

A public meeting has been scheduled for August 6, 2019. The report was received for information.

2. <u>PL-13-19 – Site Plan Approval, VIMCO, Part of Lot 22, Concession 5, being Part 1 on Reference Plan 49R-19365, Water Tower Road</u>

Karen Cronier presented the report. Ms. Cronier explained Mr. Dan Yeas has submitted an application for site plan approval for the development of a scrap iron and metal transfer and recycling centre which is proposed to be located on Water Tower Road within the Town's Industrial Park. Mr. Yeas is in the process of purchasing said lands and he has also submitted a zoning by-law amendment to create a site specific zone designation for his business as noted in report PL-12-19.

The site plan shows the proposed construction of two 40 x 40 buildings on site with a covered drive through drop off area in between the two structures. Mr. Yeas'

business VIMCO will sort and store small quantities of metal on site; an outdoor scale will be installed and a concrete metal storage area will be installed to ensure that no metals are stored on the ground, thus eliminating possible concerns of ground contamination. Empty contractor metal bins and container delivery vehicles will be located on site and Mr. Yeas is committed to installing sufficient fencing and a monitored security system to deter scavenging.

3. PW-16-2019 – Biogas and Energy Recovery Project

David Unrau, Director of Public Works, provided an overview of the report. As previously discussed during the presentation by Ontario Clean Water Agency (OCWA) and Anaergia DB Inc. at the June 24, 2019 Council-in-Committee meeting, Mr. Unrau explained the Biogas and Energy Recovery project involves upgrading the existing digester technology to convert the Waste Water Treatment Plant (WWTP) from its traditional treatment-based process to a Resource Recovery process, achieving the goal of being an Energy Net Zero Plant. WWTP biosolids sludge, which typically has low solids content, is treated in large sealed tanks using anaerobic digestion.

The proposed project involves upgrading the plant's existing digesters with Anaergia's sludge screw pre-thickeners and High Solids SMART mixers. This project will improve the digestion efficiency and will create new revenue by allowing additional biosolids and organics (from food waste or fats, oils and grease) to be brought into the existing plant from the Town and neighbouring WWTPs as well as other biosolid producers (breweries, commercial, restaurants, etc.).

The Town has been approved-in-principle to receive funding up to \$2,720,000.00, from the Low Carbon Economy Challenge fund, of the total eligible project costs.

To move forward with the planning phase of the project, staff is recommending that further engineering be conducted to refine the cost and the design of the Biogas and Energy Recovery project at an estimated amount of \$260,000.00.
