PRESENTATIONS

1. Petawawa Centennial Family Health Centre Update and Donation Presentation – Judy Hill, Executive Director and Shelley Clarke, Board Treasurer

Councillor Tom Mohns, Chair of the Petawawa Centennial Family Health Centre Board of Directors, introduced both Judy Hill, Executive Director, and Shelley Clarke, Board Treasurer.

Judy Hill provided an overview of the services provided by the Petawawa Centennial Family Health Centre (PCFHC). Ms. Hill explained the PCFHC is a community sponsored family health team which is overseen by a skills based Board of Directors. The PCFHC currently serves 8,100 patients, and the medical staff includes six physicians, three nurse practitioners, and two registered practical nurses. The PCFHC recently completed the construction of a 5,200 square foot expansion to accommodate LifeLabs, Mulvihill Drug Mart, and Ottawa Valley Physiotherapy, to better serve the needs of the Petawawa community.

On behalf of Council, Mayor Bob Sweet presented Judy Hill and Shelley Clarke with a donation in the amount of \$50,000.00 to support the expansion. Mayor Bob Sweet recognized the PCFHC as an integral part of Petawawa's Community Hub which also includes the land ambulance station, Valour JK-12 School, St. Francis of Assisi Catholic School, and the Petawawa Civic Centre.

2. <u>Celebrating 40 Years of Festival Hall – Rick Wharton, Managing Director</u>

Councillor Murray Rutz, Chair of the Festival Hall Committee, introduced Rick Wharton, Managing Director of Festival Hall.

Rick Wharton thanked Petawawa Council for their membership in the Festival Hall Consortium and for providing funding to showcase musical and artistic talent in the Ottawa Valley. Mr. Wharton explained Festival Hall is celebrating its 40th anniversary this year with a special performance by Glass Tiger on November 30, 2019; local artist Sierra Levesque will be the opening act. Mr. Wharton highlighted when he first started as Managing Director for Festival Hall eight years ago, there was approximately 8-12 local performances annually. Since that time the number of performances has increased, both in number and in variety, noting 50 performances will be held at Festival Hall by the end of 2019. So far, 20 performances are already booked for 2020. Mr. Wharton noted many capital improvements have been completed and the Hall boasts a roster of 40 volunteers, several of whom are from Petawawa.

On behalf of Council, Mayor Bob Sweet thanked Mr. Wharton for his presentation and for keeping Council apprised of the activities of Festival Hall. He congratulated Mr. Wharton and his volunteers on the 40th anniversary of Festival Hall.

At this point, 7:08 p.m., Mayor Bob Sweet vacated the Chair and exited the Council Chambers due to his declared pecuniary interest. Deputy Mayor Gary Serviss took the Chair.

CORRESPONDENCE

 Request to Lower Speed Limit on a Portion of Rantz Road – James Carmody, Chair, Petawawa Police Services Board

Councillor James Carmody, Chair of the Petawawa Police Services Board, provided an overview of the Board's request. Councillor Carmody explained since Eric Perreault made a presentation to Council in March 2019, and following the placement of the Speed Awareness Monitor on Rantz Road in June 2019, a petition to lower the speed limit on this portion of Rantz Road, near the boat launch, has been circulating locally. The petition has not been submitted to the Town of Petawawa as of yet.

Although the Speed Awareness Monitor showed 100% of vehicles traveling on this portion of Rantz Road, were travelling at or below the speed limit of 50 km/h, the issue of speed still seems to be a factor for the local residents. Councillor Carmody further explained the statistics from the Speed Awareness Monitor actually showed that 100% of the vehicles were travelling 40 km/h or less. If the vehicles are already travelling at this reduced speed, it is the opinion of the Petawawa Police Services Board, that reducing the posted speed limit from 50 km/h to 40 km/h will more accurately reflect the true safe speed of travel.
