### **PUBLIC MEETING**

1. Zoning By-law Amendment (from "Rural" to "Residential One") – Allan & Nora Stewart, Part of Lots 3 & 4, Lake Range, River Drive

The Public Meeting was opened by the Mayor at 6:33 p.m. Karen Cronier, Director of Planning and Development, advised that the Notice of Public Meeting had been provided as required under the Planning Act. The Town received correspondence from Enbridge Inc. which had no concerns regarding the application.

Ms. Cronier explained the purpose and effect of the proposed amendment is to rezone the severed lands in Consent File B027/18 from Rural (RU) to Residential One (R1) as a condition of consent. All other provisions of the Zoning By-law shall apply.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet thanked all for attending the meeting and declared the Public Meeting closed at 6:35 p.m.

### **PRESENTATIONS**

1. <u>Pembroke Symphony Orchestra – Cheryl St. Elier, Kirsten Waymann, & Laura Vokey</u>

Cheryl St. Elier, Community outreach; Kirsten Waymann, Vice President and Artistic Director; and Laura Vokey, Education outreach; of the Pembroke Symphony Orchestra (PSO) provided Council with a presentation explaining that despite its name, the PSO is very much representative of Petawawa. All three presenters live in Petawawa and are members of the PSO. The PSO has been in existence for almost 30 years and was born of an intense desire to produce beautiful music at a high level. Members of the PSO serve many functions, not the least of which is to create a venue for local musicians to volunteer their time and training to create something beautiful for its local communities. The PSO presents four formal performances at Festival Hall each year. Children 12 and under can attend the performance for free; tickets are only \$25.00 for adults and \$15.00 for students. Ms. St. Elier explained the arts are the cornerstone of tourism and the symphony is good for local merchants noting businesses that want to attract capable and smart employees often choose a location based on local cultural opportunities; the thought is that an area with lots of cultural events is likely to attract a diverse, dynamic, intelligent, and talented group of people. A community orchestra not only provides residents a way to enjoy the arts locally. but it also offers an opportunity for local musicians to perform.

On behalf of Council, Mayor Bob Sweet thanked Ms. St. Elier, Ms. Waymann, and Ms. Vokey for their dynamic presentation.
