# 1.0 Introduction

The Town of Petawawa is pursuing a Renewable Energy Approval (REA) to construct and operate an anaerobic digester at the Petawawa Waste Water Facility. Figure 1 provides a key map of the Petawawa Waste Water Facility (the Project Location). A streamlined process is in place to coordinate legislative requirements set out by various ministries under the *Green Energy Act*. Applicants must meet the requirements outlined in *Ontario Regulation 359/09* (i.e. the REA Regulation) under the *Environmental Protection Act* to receive an REA.

The REA process addresses natural heritage protection for renewable energy projects on private land and provincial Crown land in Ontario. Following the REA Regulation, the proposed bioenergy facility (i.e. anaerobic digester) is a renewable energy project that requires a Natural Heritage Assessment (NHA). Figure 2 provides an overview of the NHA process. Cambium Inc. (Cambium) has been retained to carry out the NHA for the Petawawa Waste Water Facility.

The purpose of the records review is for applicants to gather information about the area in which the project is proposed, identify natural features and make a preliminary determination about site feasibility (MNR, 2012). Applicants are required to identify specified natural features at or near their proposed Project Location under Part IV, Section 25 of the REA Regulation. As the initial step in the NHA process, this Records Review Report provides;

- A description of all records reviewed;
- Relevant supporting metadata, including the date of the information;
- List of organizations contacted;
- States if the proposed Project Location is in a natural feature, within 50 m of an ANSI (earth science), or within 120 m of a specified natural feature in the REA Regulation that is not an ANSI (earth science); and
- States if the proposed Project Location is in a provincial park or conservation reserve or within 120 metres of these features; and



• If the project is proposed within a provincial park or conservation reserve, provide evidence that the project is permitted under Section 19 of the *Provincial Parks and Conservation Reserves Act, 2006.* 

# 1.1 Project Location

The Petawawa Waste Water Treatment Facility is located at 560 Abbie Lane, Petawawa, Ontario. The anaerobic digester is proposed to be located within the existing developed lands of the Petawawa Waste Water Treatment Facility. The facility is located entirely on privately owned lands. The local municipality is the Town of Petawawa, and the upper-tier municipality is the County of Renfrew.

The Project Location, situated in Petawawa, is located entirely outside of;

- The jurisdiction of a Conservation Authority, local roads board and local services board;
- The Oak Ridges Moraine Conservation Plan Area;
- The Niagara Escarpment;
- The Growth Plan for the Greater Golden Horseshoe, and
- The Natural Heritage System of the Greenbelt Plan's Protected Country Side.

# 1.2 Description of the Proposed Renewable Energy Development

The Town of Petawawa has proposed to develop an anaerobic digester within the existing Waste Water Facility. The footprint of the proposed anaerobic digester and associated infrastructure is entirely within the existing fenced compound for the Waste Water Facility. The Natural Heritage Assessment for Renewable Energy Projects (NHAG) (MNR, 2012) defines the "project location" as "when used in relation to a renewable energy project, a part of land and all or part of any building or structure in, on or over which a person is engaging in or proposes to engage in the project." Figure 1 depicts the boundary of the Project Location.



# 2.0 Methodology

The records review was completed following Section 2.3 and Section 4.0 of the NHAG (MNR, 2012). The "project location" measurement was taken from its outer limit to the boundaries of natural features and waterbodies. The outer limit of the Project Location includes all lands in which construction, installation, use, operation, maintenance, changing or retiring of the renewable energy generation facility. The out limit includes where site preparation and construction activities (i.e. vegetation removal) will occur and where infrastructure will be installed, operated and decommissioned. Thus, the record review process was completed using the outer limit of the Project Location along a horizontal plane to the boundary of a natural feature.

All records referenced in Table 6 of the NHAG were searched as a part of this records review. Provincial and federal data sets were reviewed to prepare this report. A description of all records reviewed is provided in the References section of this report. The description includes the title of datasets, data layers and map titles. Metadata for the Land Inventory Ontario (LIO) spatial data set is provided in Appendix A. A Geographic Information System (GIS) was used to perform the records review. Where required, records were reviewed outside of the GIS. Records were collected and analyzed from LIO, the Natural Heritage Information Centre (NHIC), and other databases. The NHIC was contacted to obtain additional information on their natural heritage records. Correspondence with NHIC is not included in this report to maintain the confidentiality of sensitive data. The correspondence can be shared with the MNRF upon request.



# 3.0 Natural Features and Prohibitions on Development

The REA Regulation defines development prohibitions within and near specified natural features. Development prohibitions are outlined in Part V, Sections 37, 38, 41, 42, and 43 of the REA Regulation. The Project Location, situated in Petawawa, is located entirely outside of the Oak Ridges Moraine Conservation Plan Area and the Natural Heritage System of the Greenbelt Plan's Protected Country Side. Thus, this project is not subject to additional development prohibitions in Provincial Plan Areas (MNR, 2012) stipulated by Sections 41, 42, and 43 of the REA Regulations.



# 4.0 Results

The records review included the lands within 1000 metres of the Project Location as per the recommendation in the NHAG (MNR, 2012).

# 4.1 Records Results for Natural Features and Water Bodies

The Petawawa Waste Water Treatment Facility is located at 560 Abbie Lane, Petawawa, Ontario. The facility includes a fenced area of 2.5 hectares with buildings and infrastructure located within a cleared area. The fence forms the physical boundary of the Project Location. Lands within the fence are maintained lawn. Woodlands surround the fenced area.

Specified natural heritage features listed in the REA Regulation are not present within the boundaries of the Project Location.

The natural features located within 120 of the Project Location boundary include (NHIC, 2021): wetlands (nearest is ~80 m), a watercourse (10 m), and woodlands (immediately adjacent). In addition, the Ottawa River (Allumette Lake) is located 220 metres east of the Project Location. The NHIC search for the 1 km<sup>2</sup> atlas square 18UR2585 encompassing the site included the following records; Petawawa Terrace Area of Natural and Scientific Interest (ANSI, Life Science), Petawawa Provincial Park (Nature Class Reserve), Houghton's Flatsedge (*Cyperus houghtonii*, G4/S3), Lake Sturgeon (*Acipenser fulvescens*, Threatened), Northern Map Turtle (*Graptempys geographica*, Special Concern) and a Restricted Species (Personal correspondence, NHIC, 2021-05-27). Table 1 provides a summary of the natural features and waterbodies records review.

# 4.1.1 Savannahs / Sand Barrens / Tallgrass Prairie / Alvars

The records review did not yield records for the presence of savannahs, sand barrens,

tallgrass prairies or alvars. The project location is not within the Greenbelt or Oak Ridges



Moraine Plan areas, so Sections 41, 42, 43, 44, 45, and 46 of the REA Regulation do not apply to this renewable energy project.

# 4.1.2 Area of Natural and Scientific Interest Earth Science and Life Science

The records review yielded a record for the Petawawa Terrace (Life Science ANSI), located approximately 475 m south of the Project Location. There are no Earth Science or Life Science ANSI at or within 120 m of the Project Location.

# 4.1.3 Provincially Significant Wetlands

The records review did not yield data for Provincially Significant Wetlands, Coastal or Northern, at or within 1000 metres of the Project Location. There are no records of any wetlands at the Project Location. A record of a local wetland is present approximately 80 metres north of the Project Location.

# 4.1.4 Provincial Parks and Conservation Reserves

The records review did not yield any records of a Provincial Park or a Conservation Reserve at or within 120 metres of the Project Location. However, Petawawa Terrace Provincial Park (Nature Class Reserve) is located approximately 475 metres south of the Project Location.

# 4.1.5 Significant Wildlife Habitat

Habitat of species of conservation concern (i.e. Special Concern and Rare species) is considered Significant Wildlife Habitat (SWH) (MNR, 2014). Special Concern and Rare (S1,

<sup>&</sup>lt;sup>1</sup> The Specified Natural Features and Waterbodies listed in Sections 41 and 42 of the Regulations do not apply to this project. The Project Location is completely outside of the the Oak Ridges Moraine Plan Area and the Greenbelt Plan's Natural Heritage System.

<sup>&</sup>lt;sup>2</sup> The Waste Water Facility is a manicured lawn and infrastructure which is entirely fenced. The fenced area is not accessible to deer and is not considered a deer wintering area. It is not known if the lands outside of the fenced area possess the biophysical attributes suitable for deer wintering.

<sup>&</sup>lt;sup>3</sup> In accordance with the Guide (MNR, 2012), some development prohibitions vary in different areas of the province. Significant woodlands have development prohibitions only on lands that are located south and ast of the Canadian Shield. The development prohibition for significant woodlands does not apply because the site is located in EcoDistrict 5E-10 which is within the Canadian Shield.



S2, S3) plant and animal species or communities represent a very broad group. The following records represent candidate SWH;

- Northern Map Turtle: This record is from a 1 km<sup>2</sup> area from the NHIC Make-a-Map (grid square 18UR2585) (NHIC, 2021). Cambium undertook a site investigation on April 6, 2021. The watercourse and wetlands on site are not suitable for the life processes of turtles. The Map Turtle record was likely from the Ottawa River. Therefore, potential Significant Wildlife Habitat for this Special Concern species not anticipated to be located on or within 120 metres of the Project Location.
- *Cyperus houghtonii* (Rare, S3). This record is from a 1 km<sup>2</sup> area from the NHIC Make-a-Map (grid square 18UR2585) (NHIC, 2021). The Canadian Museum of Nature record, catalogue number CAN 521834, states this species was observed July 1, 1987, at latitude 45.9, longitude -77.25. These coordinates would place this species record along the fenceline in the southern portion of the Project Location. The record states the species was observed at Petawawa Point on the Ottawa River, and the site notes describe the habitat as a "sandy beach". The location and the description do not appear to align. The "sandy beach" habitat description is likely more accurate than the spatial location assigned to the species observation. Sandy soils on the west side of the Project Location and within 120 metres may provide suitable conditions for *Cyperus houghtonii*.
- Deer Wintering Area: Schedule B, Map 4 from the County of Renfrew Official Plan identifies deer wintering area within 120 m of the Project Location. The fenced perimeter of the property would prevent deer from utilizing the Project location. Therefore, the lands immediately adjacent to and within 120 m of the Project Location would be candidate Significant Wildlife Habitat—Seasonal Concentration Areas (MNR, 2014).

# 4.1.6 Significant Woodlands

In the past 200 years over 70 percent of woodland cover has been lost in Ecoregions 6E and 7E (Ministry of Natural Resources, 2010). The protection of woodland cover in southern Ontario is an important concern (Ministry of Natural Resources, 2010). Planning authorities are responsible for protecting significant woodlands within Ecoregions 6E and 7E in accordance



with policies 2.1.4(b) and 2.1.6 of the PPS. The amount of woodland cover is high across the landscape within Ecoregion 5E. As such, the Natural Heritage Reference Manual and the PPS do protect or designate significant woodlands within Ecoregion 5E. As such, there are no significant woodlands at or within 1000 m of the project location.

# 4.1.7 Waterbodies and Watercourses

No waterbodies are located on or within 120 m of the Project Location. The Ottawa River / Allumette Lake is located 255 metres east of the Project Location. No watercourses are located at the Project Location. An unnamed watercourse, a cold water Tributary of the Ottawa River/ Allumette Lake, is located approximately 10 metres northwest of the Project Location. The Petawawa River is located 680 m northwest of the Project Location.



# 5.0 Determination of Natural Heritage Features and Waterbodies

The records review process did not identify any specified natural features at the Project Location. The records review process yielded the presence of the following features within 120 m of the Project Location;

- Candidate Significant Wildlife Habitat;
  - Habitat for rare vegetation (Cyperus houghtonii)
  - Habitat of seasonal concentration of animals—Deer Wintering Area.
- Non-provincially significant wetlands.
- Woodlands located immediately adjacent.
- An unnamed Watercourse [a cold water Tributary of the Ottawa River / Allumette Lake]

It has been determined that natural features and a watercourse are located within 120 m of the Project Location (Table 2). Therefore, a Site Investigation is recommended as the second stage of the NHA, as required under Section 26 of the REA Regulation. The results of the records review indicate a site investigation is required to confirm the boundaries of these natural features or species at and within 120 m of Project Location. In addition, the site investigation is performed to identify any additional natural features which may exist within the site investigation area, other than those identified in this Records Review Report or on adjacent lands.

Section 3.1 of the NHAG states that natural features previously evaluated by the MNRF and determined to be significant or provincially significant, the development prohibitions of the REA Regulation apply. If the natural feature has not been evaluated, it is the proponent's responsibility to determine the significance of the feature to ascertain if development prohibitions apply or to protect the feature by treating it as significant and amending the project location to be outside of the setback from the feature. If the prescribed setback can be maintained from the feature, the applicant is not required to complete an evaluation of significance or any other natural heritage study for that feature.




