Presentations

Petawawa Police Services Board 2021 Year-End Report – James Carmody,
 Chair, Petawawa Police Services Board

Councillor James Carmody, Chair of the Petawawa Police Services Board (PPSB), introduced Board members Sharon Dainty, Provincial Appointee and Maria Morena-Church, Community Appointee.

Councillor Carmody provided a presentation regarding the activities of the PPSB for 2021. Chair Carmody touched on items such as the legislated mandate of police services boards; the Board/UOVOPP joint action plan; the Black Cat Radar Speed Awareness Monitor; the new CAMSafe Security Video Registration Program; the Community Safety and Well-Being Plan and public awareness campaigns via Facebook, radio, and billboard, regarding accidental 911 calls, distracted driving, impaired driving, and fraud prevention.

Mayor Bob Sweet thanked Chair Carmody for providing a detailed summary of the activities of the PPSB for 2021.

2. <u>Upper Ottawa Valley Ontario Provincial Police 2021 Year-End Report – Inspector Stephan Neufeld, Detachment Commander</u>

Inspector Stephan Neufeld remarked 2021 was again a year of unprecedented challenges for the OPP and the communities it serves due to the COVID-19 pandemic. Inspector Neufeld touched on the OPP's priorities and commitments, and highlighted the 2020-2022 Strategic Plan. Inspector Neufeld presented 2021 calls for service, seatbelt and distracted driving statistics compared to 2020. The 2021 statistics for seatbelt charges are 3.0% less than the previous year; and distracted driving charges are 39.5% less than in 2020. Inspector Neufeld suspects this reduction is in response to people working from home and not travelling due to COVID-19. Inspector Neufeld reported on the responsive and evolving work of the Upper Ottawa Valley Detachment in providing a significant increase in RIDE checks conducted which were 92.3% more than the previous year.

Inspector Neufeld highlighted the plans for 2022 which include the partnership between both Pembroke and Petawawa Police Services Boards to introduce the new CAMSafe Security Video Registration Program; the opening of five new Collison Reporting Centres within the East Region and Project Lifesaver which is a wander guard assistance program.

Mayor Bob Sweet thanked Inspector Neufeld for providing a detailed summary of the activities of the Upper Ottawa Valley OPP for the year 2021.
