1. Activity Report – December 2021

Deputy Fire Chief Craig Proulx provided an overview of the monthly report. Deputy Chief Proulx highlighted the monthly platoon training which focused on the open air burning by-law and smoke and carbon monoxide alarms. Deputy Chief Proulx also highlighted the installation of a new bunker gear cleaning extractor and septic tank pumping at Station 1.
