## **Presentations**

 Enbridge Gas – Franchise Agreement Renewal – Sonia Fazari, Senior Advisor, <u>Municipal and Stakeholder Engagement and Steven Rogers, Operations</u>
 <u>Manager, Eastern Region</u>

Mayor Sweet welcomed Sonia Fazari and Steven Rogers.

Ms. Fazari thanked the Town for providing the opportunity to present the franchise agreement renewal and invited Mr. Rogers to provide some historical background on the municipality and its relationship with the predecessor Consumers Gas that dates back to December 6, 1957.

Ms. Fazari outlined the renewal process for the current franchise agreement which was adopted in 2003. Ms. Fazari indicated that a renewed agreement will have a 20 year term.

Mayor Sweet thanked Ms. Fazari and Mr. Rogers for their presentation and requested questions from Council.

2. <u>Petawawa Public Library – 2021 Annual Community Report – Lisa Worobec, Chief Executive Officer</u>

Deputy Mayor Gary Serviss, Petawawa Public Library Board Chair, introduced and welcomed Lisa Worobec.

Ms. Worobec presented the Library's annual community report and highlighted its new logo. Ms. Worobec commented on the expanded hours of operation from 10:00 am to 5:00 pm on Saturdays and other strategic initiatives, including enhanced technology, redesign of space and a focus on internal culture. The number of patrons visiting the Library in 2021 totalled 22,414 with over 62,999 physical items and 11,669 digital items borrowed. Ms. Worobec highlighted the various programs that the Library conducted in 2021, including summer reading, adult outreach, early literacy and tween and teen.

Mayor Sweet thanked Ms. Worobec for her thorough presentation and acknowledged the efforts of the Board and staff in providing outstanding service to the community.
