1. <u>Zoning By-law Amendment (from "Rural (RU)" to "Residential One (R1)"), Part of</u> Lot 19, Concession 1, Barron Canyon Road, Doering

The Public Meeting was opened by the Mayor at 6:32 p.m. Karen Cronier, Director of Planning and Development, advised that Notice of the Public Meeting had been provided as required under the Planning Act. A written submission was received from Enbridge Gas Inc. whom had no concerns regarding the application.

Ms. Cronier explained the purpose and effect of the amendment is to rezone the severed lands in Consent File B192/21 from Rural (RU) to Residential One (R1) as a condition of consent to ensure the entire enlarged lot is in the same zone. All other provisions of the Zoning By-law shall apply.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present.

Mayor Sweet declared the Public Meeting closed at 6:35 p.m.

2. <u>Zoning By-law Amendment (from "Rural (RU)" to "Residential One (R1)"), Part of Lot 13, Concession 5, Black Bay Road, Silke</u>

The Public Meeting was opened by the Mayor at 6:35 p.m. Karen Cronier, Director of Planning and Development, advised that Notice of the Public Meeting had been provided as required under the Planning Act. A written submission was received from Enbridge Gas Inc. whom had no concerns regarding the application.

Ms. Cronier explained the purpose and effect of the amendment is to rezone the severed lands in Consent Files B106/21(1) and B107/21(2) from Rural (RU) to Residential One (R1) as a condition of consent to permit the severance of two residential lots. All other provisions of the Zoning By-law shall apply.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present.
