1. Request for the Creation of an Equity, Diversity, & Inclusion (EDI) Committee – Ellen Wong-Gallant and Rebecca Conroy

Mayor Sweet welcomed Ellen Wong-Gallant and Rebecca Conroy as representatives for the proposed creation of an Equity, Diversity, and Inclusion (EDI) Committee.

Ms. Wong-Gallant and Ms. Conroy outlined the importance of creating an EDI Committee for the Town of Petawawa. Ms. Conroy explained the creation of an EDI Committee would provide new opportunities for citizen engagement; provide a valuable resource for Town leaders; and provide the opportunity to learn from others in the community to ensure all residents are represented in a fair and equitable manner. Ms. Wong-Gallant reported that a petition was started in support of the creation of an EDI Committee within the past few days and 80 signatures have been received thus far. Ms. Wong-Gallant and Ms. Conroy proceeded to share stories of people in the community who have felt some form of inequity, prejudice, or exclusion.

Ms. Wong-Gallant and Ms. Conroy respectfully requested Council consider their request.

Council discussed the request and commented on the Town's committee structure; the development of terms of reference; how appointments to the proposed committee would be made; and the timing of implementing such a committee, taking into consideration the upcoming municipal election.

Mayor Sweet, on behalf of Council, thanked Ms. Wong-Gallant and Ms. Conroy for their presentation.
