### Public Meeting

1. <u>Zoning By-law Amendment (from "Commercial – Exception Thirteen (C-E13)" to</u> <u>"Residential Three – Exception Eleven (R3-E11)"), Part of Lot 13, Concession 5,</u> <u>Highland Park Drive</u>

The Public Meeting was opened by the Mayor at 6:33 p.m. Karen Cronier, Director of Planning and Development, advised that Notice of the Public Meeting had been provided as required under the *Planning Act*. A written submission was received from Enbridge Gas Inc. whom had no concerns regarding the application. Ms. Cronier explained the purpose and effect of the amendment is to rezone the 1985.8 square metres of severed land that is to be added to the adjacent existing lot in Consent File B101/22 from Commercial – Exception Thirteen (C-E13) to Residential Three – Exception Eleven (R3-E11). This will ensure consistent zoning on all of the development lands. The rezoning also modifies the R3-E11 zone provisions to the following:

- To establish Highland Park Drive as the front lot line,
- To reduce the exterior side yard setback from 7.5 m to 4.5 m; and
- To increase the maximum building height from 13 m to 15 m.

Mayor Serviss asked to hear comments from the applicant. The applicant chose not to come forward to speak on the application.

Mayor Serviss asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present.

Mayor Serviss declared the Public Meeting closed at 6:36 p.m.

# **Presentations**

1. <u>Proposed Off-Road Vehicle By-law – Teresa Hebb, Past-President and Chico</u> <u>Traclet, Director Petawawa, Renfrew County ATV Club</u>

Mayor Serviss introduced Teresa Hebb, Past-President and Chico Traclet, Director Petawawa, both from the Renfrew County ATV Club.

Ms. Hebb provided an overview of the RCATV Club and highlighted the economic and tourism potential that can be obtained through the adoption of an Off-Road Vehicle (ORV) by-law for the Town and the endorsement of an amendment to the County of Renfrew ORV By-law. Ms. Hebb addressed the RCATV membership growth since 2014 and demonstrated how the Club works to promote rider safety, address trail and resident concerns, report hazards, and support landowners.

Ms. Hebb expressed her appreciation to Council for providing her with the opportunity to appear and stated she would be happy to take any questions.

Mayor Serviss asked to hear questions from Council. Council discussed the request and commented on several aspects such as, education and rider safety, enforcement, insurance coverage, the requirement for Algonquin Trail permits as of May 1, access over shared municipal roadways, noise concerns, and the potential for a trial pilot project for use of Off-Road vehicles.

**Whereas** Section 3.1 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, authorizes municipalities to enter into agreements with the Crown in right of Canada with respect to matters within the municipality's jurisdiction;

And Whereas the powers of a municipality shall be exercised by its council;

**And Whereas** a municipal power, including a municipality's capacity, rights, powers and privileges, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

**Now Therefore be it resolved** that Council of the Corporation of the Town of Petawawa hereby authorizes the Mayor and the Clerk to enter into a contribution agreement with His Majesty the King in right of Canada as represented by the Minister of Intergovernmental Affairs, Infrastructure and Communities to receive funding under the Permanent Public Transit Program - Active Transportation Fund to construct a 1.4 km asphalt multi-use pathway along Laurentian Drive;

**And that** a copy of this resolution be provided to the Ministry of Intergovernmental Affairs, Infrastructure and Communities so that a formal contribution agreement can be prepared for execution by municipal by-law. **Carried**
