 County of Renfrew Human Resources Department & Services – Jeffrey Foss, Director of Corporate Services, Greg Belmore, Manager of Human Resources and Amanda Nesbitt, Human Resources Coordinator

Daniel Scissons, CAO, welcomed Jeffrey Foss, Director of Corporate Services and the County of Renfrew Human Resources (HR) representatives. In his introduction, Mr. Scissons provided Council with background on the current HR relationship the Town has with the County. Mr. Scissons identified that the Town could take further advantage of enhanced professional services offered by the County leading up to an organizational review, at which point the scope of inhouse HR personnel could be determined. Mr. Foss opened the presentation by thanking Mayor Serviss and Mr. Scissons and introduced his colleagues Greg Belmore, Manager of HR, and Amanda Nesbitt, HR Coordinator. Mr. Foss highlighted the structure of the HR Division under Corporate Services and the expertise available to lower tier municipalities. Mr. Belmore and Ms. Nesbitt expanded on the HR framework, the comprehensive services that can be delivered and outlined the County's cost recovery fee structure. Mr. Foss reported the HR Division has a full complement of staff capable of providing guidance on recruitment, workplace investigations, performance management, policy creation and interpretation, pay equity, job evaluations and other labour matters.

Members of Council discussed the County's service offerings and asked questions of the presenters.

Mayor Serviss, on behalf of Council, thanked the County representatives for their presentation.
