# 2. <u>PL-16-2023 – Zoning By-law Amendment – Bed & Breakfast, 1371 Victoria Street</u>

Karen Cronier, Director of Planning and Development, provided an overview of the report.

The Zoning By-law Amendment application proposes to rezone the subject property from Residential One (R1) Zone to Residential One Exception Fifty-Five (R1-E55) to permit a Bed & Breakfast. The proposed Zoning By-law Amendment does not raise any concerns of provincial significant and staff are therefore satisfied that the proposed amendment is consistent with the Provincial Policy Statement.
