# 1. <u>Activity Report – December 2022</u>

Karen Cronier, Director of Planning and Development, provided an overview of the report. Ms. Cronier reported on Official Plan Amendment #19 which has been submitted to the County of Renfrew for approval and summarized the progress on site plan applications for apartment and commercial developments. Ms. Cronier also reported on the submission of documentation to Emergency Management Ontario confirming the Town's 2022 compliance with training requirements. Ms. Cronier detailed the Official Plan Update milestones and referenced the Special Meeting of Council scheduled for March 8, 2023. Ms. Cronier advised that an open house is scheduled for January 24, 2023 to solicit public input on proposed revisions to the municipal sign by-law.

# 3. <u>PL-01-2023 – Highland Park Apartments Phase 2, Planning Approvals – Site</u> <u>Plan Approval, Zoning By-law Amendment and Consent Applications, Part Lot</u> 15, Range C

Karen Cronier provided an overview of the report. Ms. Cronier reported that the proposed site plan for the 0.65 ha development at the corner of Highland Park Drive and Civic Centre Road meets the intent of the Official Plan. A zoning bylaw amendment to consolidate mixed zoning, reduce an exterior side yard setback, establish a front lot line and increase the maximum building height will be heard in early March 2023. Consent applications for a lot addition and access, stormwater and sanitary easements have been filed with the County of Renfrew Land Division Committee. The site plan is appropriate development for the subject lands and approval will be granted subject to the passing of the zoning by-law amendment, the completion and approval of the consent applications and

the entering into a site development agreement between the applicant and the Town.
