Maryse provided photos of the two spaces, one large area and one smaller area and she provided the Legacy of Hope availability and options for the Committee to consider. Committee discussed the options and reached consensus on the preferred option and timing for the Exhibit.

Moved by Ellen Wong and seconded by Natalie Chaumont, that the Committee's preferred option for the Legacy of Hope Exhibit is Option #1 with version 2, followed by Option #5 with version 2 and finally Option #8 version 1 & 2 for display in either July or August 2023 with approved spending in the amount of up to \$500.00. Motion carried.
