# Work Plan Review

K. Bennett presented a draft list of work plan items following the requirements and implementation of Ontario's accessibility standards for customer service, built environment, employment, information & community engagement, transportation, and general legislative requirements. Many items were taken from departmental budgetary items such as construction of the Comfort Station, planning for a new municipal website, town hall renovations, staff education on the AODA and the towns responsibilities for implementing and enforcing accessibility standards. The committee reviewed the draft list and provided additional items such as a radio campaign for Accessibility Awareness Week communications, community support systems on the town website, etc. K. Bennett noted that she will place the items into a draft work plan for review at the next meeting.

#### **New Business:**

### Showcase 2023

K. Bennett provided a Showcase schedule from April 28-30th and asked for committee support to work the Showcase to provide information to residents regarding PAAC. K. Bennett noted that she spoke with C. Coyle to request if a piece of accessible equipment could be used as a display at the town booth, such as the water wheelchair or kayak as the community didn't seem to be aware of the available equipment from conversations at last years Showcase. K. Bennett further noted that it may be helpful to have an informational handout regarding equipment available for residents interested. The committee agreed and requested that the information be added to the back of the PAAC business cards and be ready to hand out at the Showcase in April.

# <u>Site Plan Review – Petawawa Comfort Station</u>

The committee reviewed the proposed site plans for the Comfort Station and noted the following:

ensure a barrier-free path of travel (1100 mm minimum) from the Algonquin Trial,

Petawawa Boulevard sidewalk and the parking area from Norman Behnke Hall;

hallways and door widths meet or exceed accessibility standards and are fully barrier-

free – PAAC recommends 42" door widths;

building has accessible features throughout such as lever door handles, lever taps,

accessible signage;

lighting level is evenly distributed throughout all accessible routes;

outdoor features and furnishes be accessible (wayfinding signage, seating/rest areas,

garbage receptacles, picnic tables etc.);

covered slab floor surface be firm and slip-resistant – maximum gradient of 1:50 (2%)

to permit drainage;

o ensure threshold is beveled at slope of 1:2 (50%) maximum, where transition

is between 6 to 13 mm; ensure door stops and door sweeps do not prevent

maneuverability; and,

o provide tactile walking surface indicators 610 mm (minimum) from edge of

elevated platform, extending the full length.

**Inclusive Community Grant** 

The committee reviewed the Inclusive Community grant guidelines and discussed possible

projects that would qualify. The committee was in favor of applying for two (2) accessible

bikes for residents to use on community trails and the possibility for the Water & Dirt Festival.

A. Tefoglou advised that she has experience with applying for grant funding and offered to

work with K. Bennett and C. Coyle to complete the grant submission request.
