# PETAWAWA BUSINESS ADVISORY NETWORK (PBAN)

The Petawawa Business Advisory Network (PBAN) is created to function as an advisory board, composed of diverse and industry-represented business leaders to provide counsel and identify business development initiatives and cultivate economic growth and wealth for Petawawa.

The PBAN meets a maximum of 12 times per year and is composed of a maximum of 10 members, one of which is a Council member. Members are appointed by Council for the term of Council. Staff is assigned to coordinate meetings, prepare subject materials, reports, and function as the conduit between the PBAN and Council.
