PUBLIC MEETINGS

1. Zoning By-law Amendment (from "Rural" to "Residential One") – Frank Durant, Part of Lot 5, Range B, Airport Road, in the Town of Petawawa

The Public Meeting was opened by the Mayor at 6:32 p.m. Karen Cronier, Director of Planning and Development, advised that the Notice of Public Meeting had been provided as required under the Planning Act. No written submissions were received regarding the application.

Ms. Cronier explained the purpose and effect of the amendment is to rezone the severed lands in File B13/18 from Rural (RU) to Residential One (R1) as a condition of consent to permit the severance of a new residential lot. All other provisions of the Zoning By-law shall apply.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet declared the Public Meeting closed at 6:36 p.m.

2. <u>Zoning By-law Amendment – Definitions (Container Market; Micro-Brewery or Brew Pub; Micro-Distillery; Mobile Refreshment Vehicle; Modular Unit)</u>

The Public Meeting was opened by the Mayor at 6:36 p.m. Karen Cronier, Director of Planning and Development, advised that the Notice of Public Meeting had been provided as required under the Planning Act. No written submissions were received regarding the application.

Ms. Cronier, explained the purpose and effect of the amendment is to add the following terms to the Definition Section of the Zoning By-law: Container Market; Micro-Brewery or Brew Pub; Micro-Distillery; Mobile Refreshment Vehicle; and Modular Unit. Micro-Brewery or Brew Pub, Micro-Distillery, and Container Market will also be added as permitted uses in the Commercial (C) Zone. All other provisions of the Zoning By-law shall apply.

Mayor Sweet asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

Ms. Cronier then explained the appeal process to those present in the audience.

Mayor Sweet declared the Public Meeting closed at 6:39 p.m.

PRESENTATIONS

1. Backyard Chickens Proposal – Laura Hanek and Jordan Rabishaw

Petawawa residents Laura Hanek and Jordan Rabishaw addressed Council regarding the possibility of allowing backyard chickens (urban hens) in residential areas in the municipality. Their presentation covered items such as: food education and security, common misconceptions, and possible concerns (zoonotic diseases, noise and odour, waste disposal). Ms. Hanek and Mr. Rabishaw highlighted other Ontario municipalities which have implemented pilot projects to allow backyard chickens in residential areas, such as Kingston, Toronto, Newmarket and Simcoe.

On behalf of Council, Mayor Sweet thanked Ms. Hanek and Mr. Rabishaw for providing their presentation to Council. Staff was directed to provide a report regarding backyard chickens for consideration at a future meeting. The presentation was received for information.

STAFF REPORTS

1. PW-14-2020 - Award of Tender PW-09-2020, Rehabilitation of Airport Road

David Unrau, Director of Public Works, provided an overview of the report. Mr. Unrau explained the funding for this construction project is provided through the Federal Gas Tax Fund. Based on bids received for earlier 2020 road construction projects, the initial scope of the rehabilitation of Airport Road was reduced to a distance of 0.65 km. Since the tendered price has come in under budget, staff is proposing to negotiate with the tenderer to extend the project limits to rehabilitate a

further section of Airport Road to exhaust the gas tax funding received, but not to exceed the budgeted amount of \$425,283.00.

Councillor James Carmody reported he too attended the grand opening for Peak Hot Yoga and wished the business owners every success.

Mayor Bob Sweet reported he attended two recent meetings of the Renfrew County Economic Task Force to review applications for the COVID-19 Business Development Fund; recipients will be announced soon. Mayor Sweet participated in a video with representatives from Garrison Petawawa and the Renfrew County and District Health Unit (RCDHU) to discuss the continued importance of adhering to public health measures and how they limit the spread of COVID-19 across our community; the video is available on the Town's Facebook page as well as the RCDHU YouTube channel. Mayor Sweet reported he also attended a recent Development and Property Committee meeting as well as a Finance and Administration Committee meeting at the County of Renfrew. Mayor Sweet attended the grand opening of Peak Hot Yoga, and he will be participating in an electronic delegation with the County of Renfrew on August 19, 2020 during the Association of Municipalities of

Ontario (AMO) annual conference to advocate for infrastructure funding for the Algonquin Trail.
