CORPORATION OF THE TOWN OF PETAWAWA

BY-LAW 279/04

A BY-LAW TO PROHIBIT THE THROWING, PLACING, OR DEPOSITING OF REFUSE OR DEBRIS ON OR WITHIN THE MUNICIPALITY

WHEREAS Section 127(c) of the Municipal Act, 2001, S.O. 2001, c. 25 provides that a local municipality may prohibit the depositing of refuse or debris on land without the consent of the owner or occupant of the land;

AND WHEREAS Section 130 of the Municipal Act, 2001, S.O. 2001, c. 25 provides that a municipality may pass by-laws for the purposes related to the health, safety and well-being of the inhabitants of the municipality;

AND WHEREAS it is deemed desirable and expedient to prohibit the throwing, placing or depositing of refuse or debris on property within the Municipality;

NOW THEREFORE the Council of the Corporation of the Town of Petawawa hereby enacts as follows:

This by-law may be cited as the "Littering By-law" for the Corporation of the Town of Petawawa.

1. **Definition – Refuse**

Refuse shall be defined as all matter thrown away as worthless or unwanted and shall include but not be limited to the common definitions of litter, rubbish, trash, garbage and waste.

2. Offence – Littering

No person shall throw, place or deposit refuse or debris on any property within the Municipality, other than those areas designated by the Municipality.

3. Fine – for contravention

Every person who contravenes any provision of this by-law is guilty of an offence and on conviction is liable to any penalty as provided for in the Provincial Offences Act.

4. Clean Up – responsibility

Every person who is convicted of an offence under this by-law shall be responsible for any and all charges, fees or costs associated with the clean up of any refuse which resulted from the original offence. The levying and payment of any fines shall not relieve a person from the necessity of paying any fees, charges or costs from which he or she is liable under the provision of this by-law.

5. Costs – recovery

The Municipality may recover the costs incurred during the cleanup resulting from any act of throwing, placing or depositing refuse or debris on Municipal property, from the person responsible for the act, by action or by adding the costs to the tax roll and collecting them in the same manner as taxes.

6. Effective date

This By-law shall come into force on and take effect upon the date of the final passing thereof.
