# Council-In-Committee Meeting Minutes May 26, 2025 at 6:30 p.m.

The Council-In-Committee meeting was opened by the Mayor at 6:33 p.m.

### Land Acknowledgement

The land acknowledgement including a Truth and Reconciliation Commission Call to Action was read.

#### **Disclosure of Pecuniary Interest**

There were no disclosures of pecuniary interest.

#### Public Meeting

1. <u>Zoning By-law Amendment to rezone a portion of the subject lands from ("Rural-</u> <u>Exception Twenty (RU-E20)" to "Residential One-Holding (R1-h)"), Part of Lot 18,</u> <u>Concession 7, in the Town of Petawawa</u>

The Public Meeting was opened by the Mayor at 6:35 p.m. Melanie Scheer, Director of Planning and Development, advised that Notice of the Public Meeting had been provided as required under the *Planning Act*.

The following written comments were received during the commenting period. Enbridge Gas did not object to the application but reserved the right to amend or remove development conditions. TransCanada Pipelines Limited asked whether concept plans were submitted, but that a future plan of subdivision submission is anticipated. TransCanada Pipelines confirmed that they have no concerns but requested a copy of the decision.

Mayor Serviss asked the planner to explain the purpose of the zoning amendment. Ms. Scheer explained the purpose of the amendment is to rezone a portion of the subject lands from Rural – Exception Twenty (RU-E20) to Residential One – Holding (R1-h). The proposed holding zone will prohibit development until a draft plan of subdivision on municipal water and sewer is approved. The amendment is a condition of approval for consent file B116/24, and if approved, the zoning by-law amendment will facilitate the severance of approximately 30 acres for a future plan of subdivision.

Melanie Scheer then explained the appeal process to those present.

Mayor Serviss asked to hear comments from members of the public. Kristan Schruder commented on concerns around the environmental impacts, travel in the area relating to increased heavy truck traffic, and to ensure a park gets build in final developments as per the agreed to plan.

Mayor Serviss asked to hear comments from members of Council. Councillor James Carmody commented on Mr. Schruder's concern over the development of a park for this subdivision and remarked that these costs will need to be considered during upcoming budget workshops. Mayor Serviss also commented that consideration to access nearby park may also be an option.

Mayor Serviss declared the Public Meeting closed at 6:47 p.m.

#### Fire and Emergency Services

#### 1. Monthly Activity Report

Craig Proulx, Acting Fire Chief, provided an overview of the report. Acting Fire Chief Proulx commented on recent meetings attended by staff during the month on significant weather events which occurred in April, and he referenced recent incident responses, fire prevention activities, and he updated the residential smoke alarm and open-air permits. Acting Fire Chief Proulx reported on the platoon training which focused on wildland fire tactics and structure defense tactical actions, as well as specialty training which focused on new recruit certifications and SCBA testing. Acting Fire Chief Proulx also reported on the participation of the Fire Department at this year's Petawawa Showcase.
