Staff Reports

 PW-25-2025 – Concerns Regarding Murphy Road Urbanization & Black Bay Road Rehabilitation – Wayne Bando, Petawawa Resident Responses to Mr. Bando's Delegation to Council on August 11, 2025

Chris Mantha, Director of Public Works, provided an overview of the report. Mr. Mantha summarized the scope of work and final design and construction cost estimate for the Murphy Road reconstruction project. Mr. Mantha further outlined the Memorandum of Understanding between the Town and the County of Renfrew to jointly proceed with the reconstruction of Murphy Road based on a 50/50 cost share split.

Mr. Mantha's report provided responses to each of Mr. Bando's concerns regarding both the Murphy Road reconstruction project and the Black Bay Road rehabilitation project. Mr. Steve Webster, Vice President, Jp2g Consultant's Inc. assisted Mr. Mantha with the presentation to Council.

Mr. Mantha concluded his report as follows, the Public Works Director corresponded with Mr. Bando over 35 times since fall of 2024 regarding the reconstruction of Murphy Road and specifically on the topics of site drainage and entrance concerns. The Public Works Director met with Mr. Bando on at least four occasions to discuss these items in person. Jp2g representatives met with Mr. Bando on site to discuss the issues as well. Throughout the entire process the Public Works Department has maintained that the properties at 227 and 221 Murphy Road had existing property drainage issues and that the reconstruction of Murphy Road mitigated road drainage impacting the property through a comprehensive design review process prior to construction. The entrance to these properties is built within regulatory guidelines and the sidewalk was designed and installed to control surface water from the road and direct the water to drywells. The Public Works Department remains committed to serving Town

residents and business owners and strives to work in collaboration during road reconstruction projects to improve the Town's road and pedestrian infrastructure.

Following discussion and comments from Council, Mayor Serviss thanked Mr. Mantha and Mr. Webster for their thorough and detailed report. Council was satisfied that Mr. Bando's concerns have been addressed.

Deputy Mayor Sabourin also attended two planning meetings on August 25th and September 2nd for the 2nd Annual Emergency & Protective Services United event scheduled for September 13th at Stafford Park in Laurentian Valley. Deputy Mayor Sabourin further attended a coordination meeting for the National Seniors Day event scheduled for October 1st at the Silver Threads Seniors Centre.

Councillor Lisa Coutu reported she chaired a meeting of the Equity, Diversity and Inclusion Advisory Committee on August 27th. Councillor Coutu also reported the EDI committee is planning a ceremony for National Day for Truth and Reconciliation on September 30th.
