1. <u>Ending Violence Alliance (EVA) Renfrew County – Erika Doell, Coordinator</u>

Deputy Mayor Theresa Sabourin welcomed Erika Doell, Coordinator with EVA Renfrew County, along with Lori Norwood and Roberta Della-Picca. Ms. Doell thanked Council for the opportunity to present this evening. Ms. Doell proceeded to provide background on the history of EVA Renfrew County and the importance of the jury recommendations from the inquest into the murders of Carol Culleton, Anastasia Kuzyk and Nathalie Warmerdam. Ms. Doell informed Council of the work the EVA Renfrew County and Victim Services of Renfrew County have done to eliminate violence against women in Renfrew County. Deputy Mayor Theresa Sabourin recommended that the Town of Petawawa consider passing a resolution declaring intimate partner violence against women an epidemic.

Be It Further Resolved That the Council for the Town of Petawawa is committed to engaging with community partners to educate and support our residents about the seriousness and long-term danger of violence in our community; and

Be It Further Resolved That the Council for the Town of Petawawa declares IPV (intimate partner violence)/VAW (violence against women) an epidemic as per recommendation #1 of the Renfrew County jury recommendations.

3. Request the Redistribution of Provincial Land Transfer Tax and GST to

Municipalities for Sustainable Infrastructure Funding – Mayor Tom Mrakas, Town
of Aurora

Mayor Serviss summarized a letter from Maor Tom Mrakas of Aurora, requesting support for a resolution advocating the redistribution of a portion of the Provincial Land Transfer Tax and GST to municipalities. This redistribution would provide a sustainable funding source for local infrastructure projects without imposing new

tax burdens on residents. It would enable better long-term planning, support local economic growth, and enhance community services.

## Resolution #13

Whereas municipalities face growing infrastructure needs, including roads, bridges, public transit, water systems, and other critical services, which are essential to community well-being and economic development; and

Whereas the current sources of municipal revenue, including property taxes and user fees, are insufficient to meet these increasing demands for infrastructure investment; and

Whereas the Province of Ontario currently collects the Land Transfer Tax (LTT) on property transactions in municipalities across the province, generating significant revenue that is not directly shared with municipalities; and

Whereas the Federal Government collects the Goods and Services Tax (GST) on property transactions, a portion of which could be directed to municipalities to address local infrastructure needs; and

Whereas redistributing a portion of the Provincial Land Transfer Tax and GST to municipalities would provide a predictable and sustainable source of funding for local infrastructure projects without creating a new tax burden on residents or homebuyers; and

Whereas a redistribution of a portion of the existing Land Transfer Tax and GST would allow municipalities to better plan and invest in long-term infrastructure initiatives, supporting local economic growth and improving the quality of life for residents.

 Now Therefore Be It Hereby Resolved That Council of the Corporation of the Town of Petawawa formally requests the Provincial Government to consider redistributing a portion of the Land Transfer Tax collected on property transactions to municipalities; and Be It Further Resolved That Council of the Corporation of the Town of Petawawa calls on the Federal

- Government to allocate a percentage of the GST collected on property sales to municipalities; and
- 2. Be It Further Resolved that this redistribution of the Land Transfer Tax and GST should be structured to provide predictable and sustainable funding to municipalities, allowing for better long-term planning and investment in infrastructure projects that benefit local communities, thus ensuring that local governments receive a fair share of the revenue to address critical infrastructure needs; and
- 3. Be It Further Resolved that copies of this resolution be forwarded to Prime Minister Justin Trudeau, Premier Doug Ford, the Ontario Minister of Finance, the Minister of Municipal Affairs and Housing, local Members of Parliament (MPs) and Members of Provincial Parliament (MPPs); and
- 4. Be It Further Resolved that copies of this resolution be forwarded to all 444 Municipalities in Ontario, the Federation of Canadian Municipalities (FCM), and the Association of Municipalities of Ontario (AMO) for their endorsement and advocacy.
