1. <u>Petawawa Accessibility Advisory Committee 2023 Year End Report, Karen</u> Donovan, Council Representative, and Lynn Davenport, PAAC Member

Councillor Karen Donovan presented an overview of the 2023 Year End Report and the activities of the Petawawa Accessibility Advisory Committee.

Councillor Donovan introduced committee members Lynn Davenport, Leah Cuffe, and Danielle LeBlanc. Councillor Donovan sent regrets for Sheila Clarke, Committee Chair, who unfortunately was unable to attend.

Councillor Donovan proceeded to explain the committee's responsibilities to fulfill the minimum standards set out in the Accessibility for Ontarians with Disabilities Act (AODA) for the Town of Petawawa and remarked on the purpose of AODA and the goal for the Province of Ontario to be fully accessible by 2025. Councillor

Donovan highlighted the activities of the Committee over the past year, such as site plan recommendations, establishing a new multi-year workplan, barrier-free workplace audits and promoting new events to spread awareness and inclusion, as well as completing the legal obligation under the AODA to file the provincial accessibility compliance report.

Mayor Gary Serviss thanked Councillor Donovan and PAAC Member Lynn Davenport for providing a detailed summary of the activities of the PAAC for 2023.
